ORDNANCE No. 12-1-22

AN ORDNANCE OF THE CITY OF BROMLEY AMENDING THE CITY'S COMPREHENSIVE PAY PLAN FOR ANNUAL SALARIES OF NON-ELECTED CITY OFFICERS AND EMPLOYEES OF CITY OF BROMLEY, KENTUCKY ACCORDANCE WITH KRS 83A.070(2) TO ADD THE NON-ELECTED OFFICE OF CITY TREASURER TO THE PLAN

WHEREAS, 83A.070(2) of the Kentucky Revised Statutes requires that the City legislative body of each city shall fix the compensation of city employees and non-elected city officers in accordance with personnel and pay classification plan; and

WHEREAS, the City Council of the City of Bromley has adopted a Pay Classification Plan for all of the employees and non-elected officers of the City of Bromley, Kentucky; and

WHEREAS, the pay classification plan as originally adopted did not include the pay for the City Treasurer,

NOW, THEREFORE, BE IT ORDAINED BY THE CITYOF BROMLEY, KENTUCKY AS FOLLOWS:

SECTION 1

The city hereby enacts and adopts, in its entirety, the Pay Classification Plan marked as Exhibit "A", which is attached hereto and incorporated by reference. The aforementioned Pay Classification Plan of the City of Bromley, Kentucky, as adopted herein, sets forth the annual salary ranges for each of the established positions within the City for the non-elected city workers, and all other city employees, including the City Treasurer.

SECTION II

All ordinances in conflict herewith are to the extent of such conflict repealed.
