2-1-83	3-1-83	Annexing a portion of the city of Villa Hills laying southwest of the City of Bromley between the south shore of the Ohio River and High Water Road.
12-1-83	- -84	Annexing certain unincorporated territory beginning at a point on the corporation line, said point being the extreme northwest corner of the corporation.
10-1-92	11-10-92	Annexing certain territory beginning at the southwest corner of the city limits, said corner being the common corner of the city limits of the City of Bromley and the City of Villa Hills on Highwater Road.
6-1-96	7-6-96	Annexing the real property described in Exhibits A, B and C, attached to Ordinance 6-1-96 and incorporated herein by reference, and as set forth on Exhibit D to Ordinance 6-1-96, a map showing the property referred to above, which is also incorporated herein by reference as if fully set forth.

7-1-95	9-2-95	Authorizing the Mayor to execute the amendment to the Dixie Police Authority Inter-governmental Cooperative Agreement, attached to Ordinance 7-1-95 and incorporated herein by reference and hereby approved by the City Council.
9-1-95	10-7-95	Authorizing the Mayor to sign the Interlocal Cooperation Agreement creating the Telecommunications Board of Northern Kentucky on behalf of the city.
10-1-97	11-1-97	Authorizing a second amendment to the interlocal cooperation agreement establishing the Telecommunications Board of Northern Kentucky.

6-4-03	6-18-03	Approving the terms of an interlocal agreement with Kenton County and other cities therein for animal control services.
10-1-09	11-4-09	Approving the terms of an interlocal agreement with Kenton County for the limited purpose of the consolidation of the administration, enforcement and collection of occupational license fee and tax ordinances of the city.

9-1-97	10-4-97	Granting a 12-year, non-exclusive franchise to TCI-TKR Cable of Northern Kentucky, providing for the construction, erection, installation, and operation of a cable television system.

7-2-94	7-2-94	Changing the name of Shelby Street, beginning at the intersection of Shelby Street and Pleasant Street and from that point extending in an easterly direction to the boundary of the City of Ludlow and the City of Bromley, and formerly also known as East Shelby Street to Oak Street.
11-2-94	12-6-94	Changing the name of Harris Street to Steve Tanner Street.
