

## **ORDINANCE NO. 5-2-21**

**AN ORDINANCE PROVIDING FOR THE LEVY, APPORTIONMENT, AND COLLECTION OF TAXES AND REVENUE FOR THE CITY OF BROMLEY, KENTUCKY, FOR THE PERIOD FROM JULY 1, 2021 TO JUNE 30, 2022.**

**BE IT ORDAINED BY THE CITY OF BROMLEY, KENTUCKY:**

### **SECTION I**

That for the fiscal year 2021-2022, there is hereby imposed, levied, and assessed a tax of point 230 Cents of each One Hundred Dollars (\$100.00) valuation of the real and personal properties including watercraft within the corporate limits of the City of Bromley, liable for taxation and not exempt from municipal taxation under the provision of this Section, and such tax shall be used and expended for the following purposes only.

## **SECTION II**

Pursuant to City of Bromley Ordinance 7-3-96 there is hereby imposed, levied and assessed a tax of point 100 Cents of each One Hundred Dollars (\$100.00) valuation of the real and personal properties including watercraft within the corporate limits of the City of Bromley, liable for taxation and not exempt from municipal taxation under the provision of this Section, and such tax shall be used and expended for repair, reconstruction or maintenance of roads and streets as provided in that ordinance.

### **SECTION III**

Pursuant to City of Bromley Ordinance 6-1-107 there is hereby imposed, levied and assessed a tax of point 111 Cents of each One Hundred Dollars (\$100.00) valuation of the real and personal properties including watercraft within the corporate limits of the City of Bromley, liable for taxation and not exempt from municipal taxation under the provision of this Section, and such tax shall be used and expended for police, fire, life squad and related emergency services as provided in that ordinance.

### **SECTION IV**

All ad valorem taxes, including road taxes and emergency service taxes previously approved and imposed by the City shall be due and payable in accordance with City of Bromley Ordinance 6-1-19 which authorizes the Sheriff of Kenton County to collect all ad valorem taxes by use of the Sheriff's practices and procedures in collection of same.

### **SECTION V**

The property taxes levied and imposed by this Ordinance, including the special taxes previously approved and imposed by the City, not paid by the due date as determined by the Kenton County Sheriff shall incur a penalty of Twenty-Five Percent (25%) and shall bear interest at a rate of One Percent (1%) per month or part of a month from the date delinquent until paid in full.

**SECTION VI**

All ordinances in conflict herewith are to that extent hereby repealed.

**SECTION VII**

The invalidity of any section, subsection, or sentence of the ordinance shall not affect the remainder.

**SECTION VIII**

This Ordinance shall take effect and be in full force from and after its passage, approval, and publication, according to law.
